**Fees:**

- **Alarm permits must be renewed each calendar year.** New alarms are \$58.00; renewals are \$26.00; and **senior citizens age 65 and older are exempt**, providing that no business is being conducted at the location.
- False alarm fees, per calendar year, are: 1st, 2nd, and 3rd false alarms no charge; 4th through the end of the calendar year are \$208.00 each.
- **First False Alarm Call for Unpaid Renewals are \$208.00 each**
- Alarm permits may be suspended, revoked, and/or police response discontinued.

**NOTICE OF CHANGE:** Whenever any change occurs in regards to the information above, the applicant shall give written notice to the police department within 20 days after such change or at any hearing conducted under this chapter if such hearing is conducted before the notice has been given (ordinance 524 (part), 1990).

**LIMITATIONS OF LIABILITY – § 11D-13:** The City of Los Alamitos is under no obligation or duty to the applicant or any other person by reason of any provision of this ordinance, or the exercise of any privilege by any applicant hereunder including but not limited to any defects in a police or fire alarm system, any delay in transmission of an alarm message to any emergency unit or damage caused by delay in responding to any alarm by any city employee, officer or agent by reason of the discontinuance or suspension of service.
