RESIDENT PARKING PERMIT APPLICATION

To apply for a resident parking permit, applicants must provide proof of residency (acceptable documents are a rental agreement, escrow papers, utility bill, driver's license, or vehicle registration). *Each adult resident must apply for a permit for his/her own vehicle; no one person may apply for parking permits for an entire household or for vehicles not registered to him/her.* Upon completion of this application, verification of residency, and verification of vehicle ownership, you will be provided with the appropriate number of *Resident Parking Permits* for each of your vehicles along with *Guest Parking Permits*.

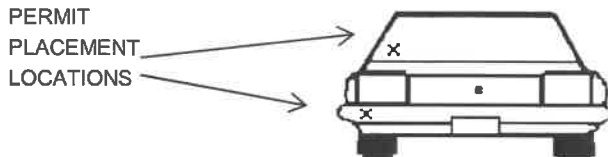
Parking permits are required for all vehicles parked on streets posted with signs indicating permit parking only. Vehicles without permits may be cited and/or towed. **It is the vehicle owner's responsibility to have the parking permit displayed properly on the vehicle (LAMC 10.24.070).**

A parking permit does not exempt the vehicle from other California Vehicle Codes, Los Alamitos Municipal Codes or any other city, county, or state codes. It is the resident's responsibility to inform guests of these parking regulations and restrictions, and to provide and retrieve temporary parking permits from guests.

Should there be any reason (special occasion, birthday, holiday, or just because etc.) you will be having more guests than you have guest permits, we will be happy to provide you with 'One Day Temporary Parking Permits'. Please notify the Police Department, at the business number provided above, at least one day prior to your event so that we will have time to prepare them for you. Please provide us with your name, address, phone number, day of your event, type of event, and how many *temporary permits* you will need. It is your responsibility to inform your guests to put their license plate number on the temporary permit, and place it face up on the driver's side dash.

Should you sell or transfer ownership of a vehicle for which a permit has been issued, or move outside of the permit area, you must return your permits to the Los Alamitos Police Department. Should you lose your permit, sell or transfer ownership of a vehicle and fail to retain your permit, you will be required to notify us immediately; in writing before another permit will be issued.

ATTACH PARKING PERMIT TO THE LOWER LEFT REAR WINDOW OR LEFT REAR BUMPER AS SHOWN BELOW.



Lost or stolen permits are **\$10 each** to replace, damaged permits may be turned in and replaced at no charge.
