The City funds a portion of the costs for the event and State Law prohibits the City from expending funds to support a campaign. As a result, no booths supporting or opposing candidates for public office, ballot measures, or other election activities other than voter registration will be permitted. Location of booth space will be made at the discretion of the City of Los Alamitos. Because of aisle clearance requirements between booths and emergency vehicle lanes, vendors will not be allowed to extend their booth beyond the allotted space.

High risk vendors must submit a certificate of Liability Insurance and Additional Insured Specific Endorsement naming the certificate holder must be submitted prior to event date, for the following certificate holder: City of Los Alamitos, and its officers, employees, agents and volunteers (10911 Oak St., Los Alamitos, CA 90720).

- Event set up will take place between 7:15-8:15am. If you are unable to arrive during set up time you will need to hand carry your items to your booth space. Your booth will have to be set and ready to greet customers by 8:30am.
- **FOOD /HIGH RISK VENDORS: a Certificate of Insurance with the City of Los Alamitos listed as additionally insured and a SPECIFIC endorsement letter is required for participation at this event. Coverage must include \$1,000,000 each occurrence and \$2,000,000 general aggregate. APPLICATION WILL NOT BE PROCESSED UNTIL ALL REQUIRED DOCUMENTS ARE RECEIVED.**
